- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications and scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarters;
- d) Name of Students admitted during the current session along with qualification, percentage, of marks in the qualifying examination and in the entrance test, if any, date of admission, etc;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
